The BVU Authority Board of Directors will hold a meeting at the above time and place to consider the proposed matters listed below and any other matter added. A meal will be provided to official attendees. The public is invited to attend.

- 1. The Chair will call the meeting to order and determine a quorum is present.
- 2. The Chair will lead the meeting in opening ceremonies:

- 3. The Chair will recognize members of the public that wish to address the board. There is a three-minute time limit for non-agenda items that may be extended with consent of the Chair.
- *4. The Chair will request a motion to adopt a meeting agenda:
 - a. The Chair will ask members and/or CEO if they have any motions to add, delete, or revise items on the agenda.
 - b. The Chair will conduct a separate roll call vote to formally adopt or reject each motion.
 - *c. The Chair will conduct a roll call vote to formally adopt the proposed agenda to include any approved motions to add, delete, or revise.

- *6. The Chair will ask for a motion to approve the following minutes:

- *7. The Chair will request a motion to approve the proposed FY2020 Water Rate Schedule as presented, which includes a rate adjustment that supports the water budget. The new rates will go into effect for all water usage after June 30, 2019. If moved, the Secretary will conduct a roll call vote. This vote is the second board approval of the rate adjustment. (Per the BVU Authority Act, only board members Mumpower, Hernandez, Bagnall and Griffin may vote.)
- *8. The Chair will request a motion to approve the proposed FY2020 Wastewater Rate Schedule as presented, which includes a rate adjustment that supports the wastewater budget. The new rates will go into effect for all wastewater usage after June 30, 2019. If moved, the Secretary will

conduct a roll call vote. This vote is the second board approval of the rate adjustment. (Per the BVU Authority Act, only board members Mumpower, Hernandez, Bagnall and Griffin may vote.)

- *9. The Chair and CEO will discuss preferred meeting schedules for FY2020 and proposed Board meeting dates. The Chair will request a motion to schedule the first FY2020 regular Board meeting. If moved, the Secretary will conduct a roll call vote.
- *10. The CEO, General Counsel, Finance Director, Customer Service and Contracts Manager, and Purchasing Agent and Warehouse Supervisor will discuss a proposed Agreement with Homeserve Warranty and Repair. The Chair will request a motion to approve the Agreement. If moved, the Secretary will conduct a roll call vote.
